## The Latest News from New York State

**NY's COVID-19 fall action plan.** Alongside statewide and national public health experts, this week Gov. Hochul shared <u>our plans</u> to get students back to school safely this fall and address any COVID-19 spikes. The state has over 20 million at-home tests that are ready to be deployed. They're prepared to reactivate State-run vaccine and testing sites if needed, and therapeutics are now widely available for those in need of care.

#### New York plans to allow third-party CDL road testers

New York Gov. Kathy Hochul announced a plan she said "will help address a critical shortage of truck and bus drivers by significantly expanding the availability of road tests for Commercial Driver License applicants."

The initiative would allow qualified third parties to offer CDL road tests, which would create more testing locations statewide and expand capacity at the existing state-run sites, reducing the time it takes to get qualified CDL drivers on the road.

The DMV will establish a monitoring system to ensure that qualified CDL trainers safely administer the road tests in compliance with state and federal regulations. The DMV will use the feedback gathered during the public hearing to evaluate and develop an implementation plan.

# News from the ATA

- Following the advocacy of movers, **FMCSA requested input on its definition of** "**brokers**"; a full copy of ATA MSC's submitted comments are **available here.**
- On June 30, the U.S. Supreme Court declined to review the California Trucking Association's legal challenge to California's Assembly Bill 5 or AB5 the independent contractor statute. The ATA has released a blog post: "AB5: What we know about CA's independent contractor statute," linked here.
- As a result of ATA MSC's request, **FMCSA** released a notice delaying enforcement until of new HHG rules until October 31, 2022. ATA MSC is working to schedule an education session with FMCSA on the new rule. Read the ATA MSC post regarding the regulations and the enforcement delay <u>linked here.</u>
- FMCSA issued a "Notice of Intent" for a rulemaking on CMV speed limiters. FMCSA's notice did not include a specific proposal for the public to comment on. ATA's comments are linked here.
- Rep. Garamendi's Base Access legislation has been included in the House's FY 2023 National Defense Authorization Act (NDAA), a positive sign moving forward. The Senate is expected to take up the annual NDAA later this year.

#### **Alternative Capacity**

There is no lack of understanding within the household goods moving industry that the driver and labor shortage is taking an even harder toll on us. There are some additional contributing factors to our peak months beside household goods that add even more volatility to transportation industry, like produce harvest, frost laws, and national holidays that hit month after month. More details on these challenges can be found in this article from ATS Inc.

With the shortage of household good drivers, greater trends of household shipments moving in alternative capacity models like Crate & Freight and No Touch Trailers are occurring in 2022.

Based on data provided by of some TSPs on dHHG, it is estimated that three to five percent of peak tonnage moves via loose-loaded freight and 25-30 percent of peak tonnage moves via crates. Until there is a fix to short-notice labor availability, this will not be a viable quality solution.

## From Harter Secrest & Emery

#### NYS Governmental & Legislative Update

This has been an eventful year in New York as it relates to government and politics. Although the end of session was conducted largely in person, the atmosphere of the Capitol was noticeably changed from the pre-COVID years. The halls were quiet, but the pace of legislation passing through the chambers was breakneck. In the final weeks of session, both houses passed hundreds of bills on a wide variety of subjects, including the Adult Survivors Act to allow adult victims of sexual assault to sue their abusers and banning the sale of cosmetics tested on animals.

All told, the final numbers show that it was one of the busiest legislative sessions in decades. The pace at which legislation passed was on a level not seen since 1995, which was over 25 years ago. All told, the Assembly and Senate passed 1,007 bills. This compares to 892 bills passed in 2021, which was record breaking at the time. The majority of the bills that passed both houses are still awaiting review and signature by the Governor.

For the Association, we are tracking nearly 80 active bills that would impact Association members. Our top legislative priority for the year was passing the illegal movers bill, S7127-A/A7994-A (Senator Andrew Gounardes, Assemblymember Michael Cusick). We are thrilled to announce that the bill has passed both houses. This bill empowers the Attorney General to enforce Transportation Law § 191, which requires movers to hold a certificate of authority from the Department of Transportation. Under current law, if someone is found to be operating as a mover without valid authority, the Department can impose a penalty and, in some instances, try to suspend the mover's drivers' license. However, the penalties are such that a violation results in a minor fine that does not serve as a deterrent to others. This bill will allow the Attorney General to seek an injunction or otherwise restrain an illegal mover from operating. The bill would also allow the Attorney General to sue an illegal mover, and courts may impose a penalty of up to

\$1,000 per violation. This bill is intended to curb illegal moving in New York and give real teeth to the penalties for those engaging in illegal moving.

The bill has not yet been sent to the Governor, but we have been in contact with the Governor's office outlining the importance of the bill and the Association's strong support. We have urged her to sign the bill into law. If signed, the bill goes into effect 90 days later. We will keep you posted on any and all developments related to this bill.

Additionally, the Legislature passed significant legislation impacting the business community in New York. Issues addressed include passage of a bill giving the Department of Labor more power to enforce the New York HERO Act. Under the bill, the Department of Labor will now be able to investigate, impose fines and find violations of the HERO Act. Finally, the Warehouse Worker Protection Act passed, which will regulate warehouse worker productivity quotas used by companies such as Amazon. The bill gained momentum and passed due to the recent stories related to high reports of injuries of Amazon warehouse workers in New York. We monitored this legislation carefully and had numerous meetings to ensure that the legislation would not impact Association members. In the end, the bill was amended to make clear it only applied to warehouses that impose quotas on their warehouse workers.

While the legislative session concluded on June 3, 2022, the Legislature briefly return for a special session right before July 4<sup>th</sup>. This special session, which was called by the Governor, was in response to the Supreme Court decisions to overturn *Roe v. Wade* and New York's longstanding concealed carry law. In response, the Legislature passed expanded gun control laws and the Equality Amendment. As a constitutional amendment, the Equality Amendment needs to be passed by the Legislature again next session, before it goes before voters in the November 2023 elections.

In the meantime, we are fully in campaign season. The primary for statewide office holders and those running for the New York State Assembly was held on Tuesday, June 28. These initial primary elections saw Governor Kathy Hochul, and her running mate Lieutenant Governor Antonio Delgado, easily win the Democratic nominations. On the Republican side, Congressman Lee Zeldin, and his running mate, Alison Esposito, secured their parties nominations for Governor and Lieutenant Governor. For the Assembly primary, the majority of Democratic incumbents who faced primary challenges beat those challenges. For the New York State Senate and Congressional races, the primary elections will be held on Tuesday, August 23.

The New York State general election will take place on Tuesday, November 8, 2022. While we don't yet know the final election results, we do know that there are many members of the Legislature who are retiring or seeking other office. As such, we know there will be many new members joining the Legislature for the 2023 session, and we know that the chair positions of many key committees will be changing for the next legislative session. We will be tracking all of these movements accordingly and working to meet and educate new members on the industry and your issues for the 2023 legislative session.
